Others Key Terms & Conditions

1. Material will be procured in single supply rapid delivery basis.
2. Rates must be valid for 90 days which will effect from opening date of Financial Proposal. Participants will be responsible to maintain their rates till the end of this period. PIA issue P.O as per its requirement/time frame, therefore no pressure from any bidder(s) shall be acceptable in obtaining order.
3. Participant must be registered with Sales Tax authorities and posses NTN Certificate.
4. Parties must carefully read all terms & conditions, if acceptable then submit their quotations. In case of violation of these rules, the same party will be restricted to participate in future tenders of PIA.
5. All participants are required to mentioned their rates inclusive all applicable Taxes/levies.
6. Payment term are net thirty days Income tax @ 3.5% and other Govt taxes/levies will be deducted from bill/invoice at source.
7. All participants are required to quote one rate and best delivery period.
8. Please note that quoted rates must be firmed and final in all respect.
9. Sample can be seen in the office of Purchase commercial Section (If required).
10. Delivery must be made at PIA Procurement & Logistics Building, Karachi Airport. If material will not be found as per approved sample or poor/mixed quality the same quantity will be reject and return to party for replacement purpose.
11. Quantity of material can be increased/decreased by $\pm 25\%$ or subject to requirement.
12. PIA reserves the right to accept or reject any tender after assigning proper reason.
