1. SCOPE OF WORK

Bid Evaluation Criteria:

The Bids shall be evaluated on the basis of competitive offers. Therefore, all bidders are required to offer bids complete in all respects as incomplete documentation will lead to disqualification of the bidder.

Security Deposit:

The firms are required to submit pay order equal to 5% of total bid cost in favor of Pakistan International Airline as "Security Deposit". The same shall be released immediately to the bidders who fail to win the bid. The security deposit of three highest bidders shall be retained with the Authority till finalization of sale process. Bids without security deposit shall be declared "Non Responsive".

Acceptance / Rejection of Bids:

On the basis of evaluation, the successful bidders will be informed accordingly with intimation to others the grounds for rejection of their bids.

Mode of Payment:

After completion of sale process, the successful bidder shall be bound to clear all dues and payments before taking over the assets as per the schedule below.
